 - o Shared with UAN at September 2022 meeting
- Motion and vote motion to adopt the attached statement as the Diversity, Equity, and Inclusion Statement representing the Advising Community at the UofSC
- Statement was adopted by the UAN members

Hardship Withdrawal website link

Kelsey McGarrigan Josh Weakland

- Kelsey is the coordinator and located in Patterson Hall
- It is not guaranteed to be approved. Committee makes the decision and look at many factors. Criteria is on the website for the hardship withdrawal process.
- Hardship occurs during the WF period of a semester or a previous period. During the WF period can apply for a hardship withdrawal, will have a decision before the end of the semester. The student will have to go through the process rather quickly. Previous semester, they have up to 2 years to withdraw from a semester.
- Outside of the 2 years, do have the ability to review but it is highly unlikely to move forward.
- Up to 2 years to apply for a hardship withdrawal
- Takes 45-60 days for the student to go through the process. Students have to complete application and then to provide the documentation
- Committee meets once a month
- Tuition refund if hardship withdrawal is approved, tuition refund is a separate process.
- Tuition refund is full withdrawal. Not connected to Hardship Withdrawal
- No special notation on the transcript. It will reflect a W.
- Have option for applying for partial due to very exceptional circumstances and cannot be academic rigor and difficulty.
- Columbia undergrad students only can apply
- Committee does have medical and mental professionals
- Students must meet with Josh to discuss the hardship process and prevent the snowball effect for the next semester. Create a plan for the student and connect with folks on campus to help the student
- If a student mentions they plan to withdraw from the university, please have the m complete withdrawal inquiry form.
